<u>Setup</u>

Everyone must check in at the front desk inside the Flagler Palm Coast High School entrance by the flagpole. Sponsor set up is anytime from 3:30-7PM. General exhibitor set up times will be sent to vendors via email in March 2026. Sponsors, please have any information you want put into the vendor bags submitted to Rikke McHugh by February 28, 2026.

No exhibit material or appurtenances shall be affixed to or fastened to the interior or exterior walls, floors or structural areas of the building by any means (nails, screws, etc.). Exhibitors are located in the school, adjoining hallways and the east courtyard.

Security

Security is the responsibility of each exhibitor. The Flagler County School District assumes no responsibility for any loss to exhibitor by theft or otherwise. No valuables are to be left unattended.

Booth Construction

Each booth will have steel pipe construction 8' high back draped, 36" high side panels-draped, 2 chairs, trash can, & skirted and covered table.

Breakdown

Breakdown will begin no earlier than 4PM on Sunday, March 29, 2026. Completion of breakdown must be done by 6PM. This will be strictly enforced. Violation of any policies may prohibit participation in future shows. (See Terms & Conditions - #20. Care and Removal of Exhibits)

Drawings and Giveaways

No announcements can be made at the show. There cannot be any exchanging of money from your table as it relates to drawings and giveaways. Any winner of a drawing or giveaway must be notified after the show ends.

Area Assignments

Home Show management assigns booths and tables. Previous years vendors will have until October 1, 2025 to claim their booths. Payments are non-refundable, including weather. No TV's/VCR's are permitted in any Service Fair Display. Electricity is not available in the Service or Art Fair.

Political Advertising

School Board Policy 904, paragraph VII, subsections G and H, strictly prohibits political and religious advertising.

Deadline

Exhibit booths will be increased by \$50 if application and/or payment are not received or postmarked by January 1, 2026.

Payment and Registration

Registration fees include advertisement in local media. All gym and bulk vendor fees include a 1/8 page advertising ad. (There is a strict deadline date to receive your advertisement. Sign up before the deadline.) Additional ad space may be available for an additional charge. The advertising entity will contact you once you have registered and paid in full.
